The undersigned Releaser(s) hereby represent and warrant that they are the parent(s) or guardian(s) of _____ ("Minor").

In consideration of the Minor being permitted to participate in _____, which is to be held on _____, 20____ ("Event") and being conducted by the Greeley Independence Stampede, Releaser(s), for themselves and the Minor, their spouses, legal representatives, heirs, successors, and assigns, hereby release, waive, and discharge the Greeley Independence Stampede, its directors, officers, members, promoters, sponsors, advertisers, owners, and any other parties who may have liability to the Minor or Releaser(s) for injuries of damages sustained by the Minor or Releaser(s) and caused by the Event (hereinafter the parties released shall be collectively referred to as the "Releasees"), from all liability to the Minor or the Releaser(s) their spouses, legal representatives, heirs, successors, and assigns for any and all loss or damage, any claim or damages resulting from the Event, on account of injury to the Minor or Releaser's person or property, even injury resulting in death of the Minor, when caused by the negligence of the Releasees, or otherwise while the Minor is participating in the Event.

On behalf of the Minor and themselves, Releaser(s) acknowledge that the Event is a dangerous activity and that participation in the Event exposes the Minor to a substantial and serious risk of property damages personal injury or death. Releaser(s) acknowledge that Minor's participation in the Event will involve such a hazard. Being fully aware that participation in the Event will expose the Minor to risk of property damages and/or personal injury or death, Releaser(s), on behalf of the Minor, hereby release the Releasees from liability for any and all property damages, personal injuries or other claims arising from participation in the Event, including claims that are known and unknown, foreseen and unforeseen, future or contingent. Releaser(s) shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit or other proceeding against any or all of the Releasees arising out of or related to the actions, causes of action, claims and demands hereby waives, released or discharged by Releaser(s), personally and for the benefit of the Minor. This provision shall be binding upon Releaser(s) and the Minor, their spouse, legal representatives, heirs, successors, and assigns.

Releaser(s), hereby agree to defend and indemnify Releasees and to hold the Releasees harmless from any liability, claims, demands, causes of action, loss or damage occasioned to the Releasees, or any of them, arising from the Minor's participation in the Event or any breach by the Minor or Releaser(s) of any obligations or covenant of Minor or Releaser(s) hereunder.
