Outdoor Booths provide space only, access to 110volt electrical outlet (see attached pricing). Linear foot charge is based on booth frontage (“tip to tail-including all overhangs.”) We recommend that each exhibitor provide a tent or canopy to protect your products from the weather.

**2008 GREELEY STAMPEDE
EXHIBITOR/VENDOR RULES AND REGULATIONS**

These Rules and Regulations governing the Stampede (Event) are provided to advise Exhibitors/Vendors of their rights, restrictions and requirements. PLEASE READ CAREFULLY & SAVE.

1. The Stampede Committee will endeavor to assign the space requested, however in case of multiple requests for the same space, the Stampede will assign to the earliest paid in full applicant. The Stampede retains final decision on space assignments and reserves the right to adjust charges if justified.
2. The Stampede reserves the right to refuse space, which would in any way detract from the dignity of the event.
3. The cowboy figure known as "The Top Hand" is used by the Greeley Stampede Committee as its logo and is registered property of the Committee. Neither the logo nor the name "Greeley Stampede" shall be reproduced on items for sale royalty rights for such usage may be awarded under separate contract.
4. Any special carpentry, wiring, telephone, gas, steam, water or drainage connections shall be arranged and installed by the exhibitor/vendor at his expense with permission from the stampede.
5. Exhibitor, at his own expense, must drape, cover or remove unsightly structures if exposed to public view.
6. All labor, materials and equipment necessary for setting up or removing exhibits shall be supplied by the exhibitor/vendor.
7. Exhibitors/vendors are to have their booth set up and ready by Event opening, otherwise the space will be declared forfeited and may be reassigned.
8. All exhibits must remain intact and staffed during the hours the Event is open to the public. Access to exhibits will only be allowed two hours before and one hour after the open hours of the Event each day. Vehicles will not be allowed adjacent to exhibits/ booths unless they are on display.
9. The decision of the Stampede's management must be accepted as final in any disagreement between exhibitors/vendors or in the decision to remove from the Event any exhibitor/vendor or his representative performing any act or practice which, in the opinion of the Stampede's management, is objectionable.
10. The Stampede is not responsible to Exhibitors/Vendors for the receipt of any parcel delivery.
11. Indemnification- Insurance: Exhibitor/Vendor agrees to defend and indemnify and hold harmless the Stampede from any loss, damage, claim, suit, action or other liability, including, without limitation, court costs and attorney fees, arising from or relating to any act or omission, whether intentional or negligent, of Exhibitor/vendor, Exhibitor's/vendor's agents, guests or invitees, or third parties.

Exhibitor/Vendor shall carry a general public liability insurance policy with a limit of \$1,000,000 for bodily injury and death per occurrence and \$1,000,000 for property damage.

Exhibitor/Vendor, for itself, its heirs, successors, and assigns, hereby releases/waives any and all claims, damages and losses arising from or relating to the acts or omissions, whether intentional or negligent of third parties or an act of God.
12. Exhibitor/Vendor is required to pay any and all tax due and payable to the State of Colorado and the City of Greeley while operating a concession booth at the Greeley Stampede. The vendor must provide the Stampede a copy of any sales tax reports filed with any governmental agency in connection with the Greeley Independence Stampede.

The Greeley Stampede Committee requires all Vendors to have liability insurance coverage for their operations during the Stampede celebration. This has caused some difficulty in past years for some of the exhibitors/vendors.

The Stampede will be able to supply you with general liability insurance through a blanket-type policy written with our insurance carrier. The policy will be written in the name of the Greeley Independence Stampede with the exhibitors/vendors named as Additional Insured's with an aggregate limit of \$1,000,000. The coverage will be effective from June 25 through July 6, 2008. The cost for this insurance is \$175.00 per vendor for the length of the Event.

A list of exhibitor's/vendor's names, addresses and the type of products/services to be provided has to be submitted to the insurance carrier prior to the Event. If you desire this coverage, please complete the bottom portion of this letter and return it along with your **cashier's check or money order** for \$175.00, made payable to the Greeley Stampede, by March 30, 2008. There is **NO** refund on any insurance premium paid.

VENDOR RV PARKING SPACE REQUEST

The Stampede has a limited number of RV Spaces available for the Event. They will be assigned on a first-come, first served, reservation basis only. **THERE IS A LIMIT OF 2 RV SPACES PER VENDOR.** After the available spaces are reserved we will set up a waiting list. Spaces will accommodate RV's up to **35 feet** in length. **TIPOUTS WILL BE RESTRICTED.** **ALL SPACES WILL BE ASSIGNED.** Assignments will be sent out May 2008. If you have any **"SPECIAL NEEDS" OR REQUESTS** please indicate this information below. One (1) Concessionaire parking pass will be included in the RV space fee.

Space fee for the event, starting June 23 and ending July 7, will be \$350.00. Additional days will be a \$25 per day fee. One (1) 110v 20amp electrical outlet will be available, as well as potable water. There are no direct sanitary sewer hook-ups, however, there are two dump stations in Island Grove Park.

RV'S WILL NOT BE PERMITTED TO OCCUPY SPACE EXCEPT IN DESIGNATED "RV" PARKING SPACES. THE DUMPING OF GREY WATER ONTO THE GROUND IS NOT ALLOWED AND WILL RESULT IN REMOVAL FROM ISLAND GROVE PARK.
